# Essay Competition - Terms and Conditions

# Back to the Competition Page Eligibility:

- This essay competition is open to current law students at accredited educational institutions, and those that may have completed their studies but are still searching for pupillage and are a member of an Inn
- Entrants must be able to provide valid proof of their student status, such as a copy of their student ID, a copy of their Inn ID or an official letter from their educational institution.
- Employees, affiliates, and immediate family members of the organisers and judges of the Competition are not eligible to participate.

### **Entry Requirements:**

- To enter the Competition, participants must submit an essay that complies with the essay guidelines.
- Only one entry is allowed per participant.

### **Essay Guidance:**

Essays must adhere to the following guidelines:

- The essay must be written in English.
- The essay should not exceed 1,000 words, excluding citations, sources, and references.
- Entrants should include citations and references in accordance with Practice Direction (Citation of Authorities) [2012] 1 WLR 780.
- The essay must not include the entrant's name, contact information, or any identifying information within the document itself. All identifying information should be provided separately during the submission process.

#### **Submission Process:**

- All entries must be submitted electronically through the 4PB website by 5pm on 7th November 2024.
- Entrants must provide their name, contact information, educational institution, and proof of student status in a separate cover letter or submission form. This information will be kept confidential and will not be visible to the judges during the evaluation process.

### **Evaluation and Judging:**

Essays will be evaluated based on the following criteria:

- Originality of ideas
- Clarity, coherence and impact of writing
- Relevance to the competition's theme or topic
- Proper citation and use of sources

A panel of qualified judges selected by the organisers will review and score the essays anonymously.

The decision of the judges is final and binding.

#### Awards:

The judging panel will select one essay as the winning entry and up to two additional essays as the runner(s)-up.

## The Essay Competition winner will be awarded:

- £500 monetary prize,
- The opportunity for their essay to be published in the Family Law Journal.
- An invitation to the 4PB Finance Group Annual Seminar and Reception on Wednesday, 27th November 2024,
- An invitation for a mini-pupillage.

# The Essay(s) selected as a top entry will receive:

- An invitation to the 4PB Finance Group Annual Seminar and Reception on Wednesday, 27th November 2024,
- An invitation for a mini-pupillage.

All entrants will be invited to the reception at the 4PB Finance Group Annual Seminar.

### Payment of Monetary Prize and Consent for Bank Details:

- Monetary prizes will be paid by bank transfer.

- Plagiarism will not be tolerated. All submitted essays will be checked for originality, and any essay found to contain plagiarised content will be disqualified.
- Entries prepared with the aid of artificial intelligence will be disqualified.

### Announcement of the Winning Entry and Top Entries:

 The winners will be notified via the contact information provided during submission. The results will also be posted on the Competition Website/Platform and through other communication channels chosen by the organisers.

### Privacy and Personal Data

- The organisers will handle all personal information in accordance with the <u>4PB Privacy Notice</u>.
- Personal information will only be used for the purposes of the Competition and will not be shared with third parties without consent.
