Profile

Dorothea specialises in the law in relation to children. In private law work Dorothea is regularly instructed in cases involving international and internal relocation of children and families and has experience of dealing with Hague and non-Hague jurisdictions on both temporary and permanent applications for removal from this jurisdiction.

Her practice covers all areas of legal parenthood involving adoption, surrogacy and the legal recognition of parental status.

In public law care proceedings she is instructed on behalf of Local Authorities, parents and most often on behalf of the children through their Children's Guardian in the most serious types of care proceedings involving allegations of sexual abuse, child sexual exploitation, serious injury and honour based violence. She has a continuing particular interest in questions of the Court's jurisdiction in public law cases with an international dimension.

Dorothea sits as a Recorder on the South Eastern Circuit.
